Rules & Regulations

- 1. A reservation is valid only after the security deposit is received by Camp Sonlight rental agent.
- 2. The Camp Sonlight rental agent must receive the following on or before the Monday preceding the use of the facilities:

a. Projected time of arrival
b. Listing of all staff members
c. Listing of all campers
f. Certificate of insurance
g. Red Cross certification for life guard (if applicable)
h. Assignment of doctor, R.N., L.P.N., or paramedic

d. Total number of campers i. Outline of camp or retreat schedule

e. Room assignments

- 3. Use of motor vehicles on camp property, with the exception of arrival and departure, is prohibited. 4. Vehicles will be parked in designated areas only.
- 4. At the pool, the "buddy system" must be used and checks made periodically.
- 5. Swimming is only allowed when a lifeguard is on duty. All safety rules for the pool area must be followed.
- 6. All firearms/weapons are prohibited from being brought on the camp premises.
- 7. Use of drugs is strictly prohibited unless prescribed by a physician and must be kept and administered by the Lessee's designated medical personnel. "Over the counter" medication is to be kept and administered by designated medical personnel. All medications must be kept in its original container.
- 8. The possession or use of alcoholic beverages is prohibited.
- 9. Smoking and the use of tobacco products on camp property is prohibited.
- 10. Boys and girls may not be mixed in cabin assignments.
- 11. There must be adequate supervision in each living unit:
 - a. No less than one adult per eight boys or one adult per eight girls.
 - b. Adults must be at least 18 years of age.
 - c. Adults must sleep in the same dorm or room as campers.
- 12. Vandalism, destruction of property, or tampering with equipment is prohibited. Costs for damages cause by the Lessee will be paid by the Lessee.
- 13. Cameras or videotaping in bathrooms is strictly prohibited.
- 14. Camp fires are allowed only at the fire ring or designated area and must be supervised by an adult.
- 15. Beds, mattresses, or covers are not to be moved or rearranged.
- 16. Pillows, bed linens, towels, and personal effects are to be provided by the Lessee.
- 17. No food/drinks allowed in any building, cabin/dorm with the exception of the dining hall and canteen area.
- 18. The privacy of the Camp Sonlight Manager is to be respected at all times. Lessee is only allowed on or near the Site Manger's property for official business.
- 19. All equipment used by the Lessee is to be returned to its proper place. This includes recreational, pool, and kitchen equipment.
- 20. Use trash cans provided throughout the camp grounds.
- 21. All trash in living quarters is to be picked up and emptied daily into the cans outside the entrance doors.
- 22. All food, dish cloths, detergent, and kitchens supplies, with the exception of cooking utensils, are to be provided by the Lessee.
- 23. All utensils, tables, and food service areas will be cleaned daily. The floor of the kitchen must be swept and mopped daily and immediately prior to departure. All food items must be removed before departure.
- 24. No pets are allowed on camp property.
- 25. Not motorhomes are allowed on camp property.
- 26. The pool and canteen gates, kitchen, dining hall, and social hall doors must be closed and locked each night. All non-essential lights, appliances and air conditioning units must be turned off each night.
- 27. Conduct and attire must reflect a Christian attitude.
- 28. The Camp Sonlight name or logo may not be used without prior written approval of the Camp Sonlight Board of Trustees.

All persons renting/leasing the Florida Primitive Baptist Camp and Conference Center (Camp Sonlight) must abide by all rules and regulations in this and the Camp Sonlight Lease Agreement.
